Item 4 Other Business Activities

Gordon Haave is a managing member and partner in BHFMM, LLC and BHFMM Media, LLC.

BHFMM, LLC: BHFMM, LLC is an affiliate of FTA. BHFMM is an insurance field marketing organization ("FMO"). A FMO acts as a wholesaler of insurance products, including annuities, to independent insurance agents across the country. Some of the independent insurance agents who use BHFMM's wholesaler services also participate in FTA's Managed Money Program. BHFMM receives a sales commission direct from the insurance or annuity underwriter for product sales made by agents using its wholesale services. The wholesale sales commissions paid to BHFMM are in addition to the sub-advisory fees charged by FTA to participating IA Firms. BHFMM provides sales training and support to insurance agents and IAR's from participating IA Firms. BHFMM does not charge additional fees for those services.

BHFMM Media, LLC: BHFMM Media provides commercial and digital marketing support to BHFMM agents. This support includes purchasing radio advertising time and digital ad placement. Other services include radio and video production, and script writing for radio programs or podcasts. BHFMM Media charges a fee for its services in addition to its sub-advisory fee for IA Firms.

Mr. Haave is a licensed insurance agent in the state of Missouri. Mr. Haave spends less than 1% of his time is spent in his insurance practice. In that capacity, he will provide advice on various insurance products. Mr. Haave only sells insurance products in states where he is holds an insurance license.

Mr. Haave is the Managing Director of Agora Trust, the Director at Universal Fusion Ltd and the Director at Universal Fusion Capital LLC, and a Director at Coinrush Ltd. These companies do not have commingled clients and are not in the financial services business.

Item 5 Additional Compensation

Mr. Haave does not receive any performance-based fees.

Mr. Haave receives additional compensation from BHFMM, LLC and BHFMM Media, LLC and is a licensed insurance agent. Mr. Haave receives additional compensation for his role as the Managing Director of Agora Trust. Mr. Haave does not himself sell directly to FTA clients, but BHFMM receives commission revenue from the sale of insurance products by insurance agents associated with BHFMM.
